We are writing from Scotland to ask that should you decide on custodial sentences for the above that you will consider that the jail time they have already served is adequate. We are particularly concerned about the threat to the health of these defendants from incarceration during the COVID-19 emergency. Another alternative is home confinement as a humane and reasonable alternative to jail.

None of the seven, who have spent their lives in helping others, pose any threat to public safety.
